o	The MSBA appoints two members on the committee, the building trades have a committee member, and others are appointed. The MSBA has the prescribed rules of setting that up on their website. D&W can forward that to the committee. M. Moran asks if designer goes through pre-qualification to get on the list. T. Elmore responds saying no, that they submit their proposals that are reviewed in the DSP, as well as spend a long time trying to get their first project. This is due to needing a history of doing school buildings. This is a major component of	
o	the designer RFS. Many times, architects have said they've had to compete on projects for years before they get their first job. S. Meyer asks if the committee scores the RFS. T. Elmore responds saying that the MSBA does not want the committee to make decisions on a designer prior to going to the designer selection panel. The committee can discuss the experience of

Elmore responds saying no, the architects are interviewed by the designer selection panel. The committee can attend and view the interview process as it is remote.</li></ul>	
0	S. Meyer asks about if the list of architects is shortened or if there will be many interviews. T. Elmore responds saying once D&W get proposals from architects, we will send them out electronically to the MSBA DSP and the SBC committee to review. Then the committee and D&W can review proposals and look at the pros and cons of each firm, the committee cannot decide on a designer. Then at the Designer Selection Panel the members will vote, each member can rank who they think should be the designer. Then they will vote for the first-place with three points. The second-place vote with two points. Then the third-place vote with one point. This goes around to the fifteen members of the DSP committee. They add up first place, second place and third place. Typically, then they will invite two to four designers to interview. The interview takes place two weeks later, each firm gets twenty-five minutes. They go through the same process as before; the highest scoring designer gets	
0	selected. M. Ward asks about the model school program. T. Elmore responds saying to still exists, but it is rarely exercised as an option. The committee won't make these desirions until the	
o	option. The committee won't make these decisions until the feasibility study has been done and discussed. M. Varakis asks if they can see a tour of certain schools to see examples. T. Elmore responds saying the architect or D&W can make arrangements to have a building tour.	

	<ul> <li>M. Moran asks when schematic design starts. T. Elmore says this phase starts when the designer is brought on board. The architect will first identify the education program, which is going to be drafted out for them prior to them coming on board. Then they will spend a month with all their consultants going through this building and identifying everything that either works or doesn't work and needs to be replaced. Then they will put a scope together of what this building would cost to just repair it and bring it up to code standards for the next fifty years. This becomes the base repair model. Base repair is usually a big number due to multiple factors such as building code, ADA compliance, and market conditions. They also look at renovation, Addition/Renovation, and new building. M. Moran asks if the base repair is reimbursable, and T. Elmore responds saying that it isn't unless it includes meeting the educational needs identified in the early stages.</li> <li>K. Turcotte asks if in the design process could include rooms that are designed to be designed to have multiple functions that are flexible spaces. T. Elmore responds saying yes that is discussed among the committee. Working groups can serve as a great medium for this type of discussion as well.</li> <li>Executive advisory group – T. Security and Student Safety Goals - (Example: "The building should be designed to have safety zones throughout the building in the case of an emergency.") - **Proposed Summary Statement: "The building key card access should be limited to faculty and students during school hours. All rooms should be lockable for safety "lockdowns" and have remote access alarms and security cameras. Entrances should have vestibules with two door entry system, with opening buzzers and video cameras. The grade configurations should be separated so the upper elementary grades (4-6) and the more junior high grades (7-8) are kept kind of separate with maybe the common areas (office, gym, cafeteria) in between them.**"




